The Tri Commission Meeting and respective Special Commission Meetings were called to order and/or reconvened at 1:09 p.m. The Pledge of Allegiance was conducted and roll call was taken. Justin Erickson, Chelan County PUD, facilitated the meeting.

TRI-COMMISSION UPDATES:

- Chelan County Commission
 - Project Coordination MOU Commissioner Gering
 - Concerns that there have been times when we are not effectively coordinating.
 - The Regional Port shared the Douglas County example of coordinating meetings.
 - The Chelan Douglas Regional Port will take lead on coordinating meetings between one commissioner and one staff member from each entity.

- o Radar Gap: Weather Forecasting Jason Detamore
 - Provided information on the radar gap in Central Washington and discussed how currently doppler radars are unable to detect short intensity storms that create public safety issues for the region.
 - Federal funds are being sought out to conduct a feasibility study on smaller radar locations.
 - The Chelan Douglas Regional Port will share concerns with Senator Cantwell during a scheduled upcoming meeting.

Chelan Douglas Regional Port Authority

- o Malaga Economic Development Jim Kuntz
 - Microsoft is proceeding with constructing three (3) buildings as part of a data center being built in Malaga. Kuntz complimented the PUD and County permitting process.
 - The Regional Port continues to work with Microsoft in acquiring additional property to construct three (3) additional buildings as part of the project.
 - The many benefits of the project were discussed, including but not limited to, the creation of approximately 75 jobs per building and large tax revenue implications for Chelan County.
 - Water infrastructure is being built out with plans for future phases that will not only benefit Microsoft, but the surrounding community as well.
 - The Regional Port is developing a cooling water disposal system. Water testing will determine what future uses the water might have.

Chelan County PUD

- o 5th Street Redevelopment Dan Frazier
 - Discussed the long process the project has taken and thanked the Regional Port for their assistance.
 - The goal is still to complete the project according to the community vision document and work is currently being focused on the back portion of the site.
 - Work is being conducted on a purchase and sale agreement to sell the Fish & Wildlife building and the adjacent parking lot to Music Theatre of Wenatchee.
 - The YMCA has two (2) lots targeted with a draft purchase and sale agreement being negotiated.
 - A schematic design for the project has been released.
 - Work is being done to look at the integration of roadway to enhance uses.
 - Discussion on the Fleet Shop as a prospect for adaptive reuse.
 - Once the back portion of the site is complete, then the priority will turn to the front portion with the idea to create a high-revenue reuse such as a hotel with street-level storefronts.
- Service Center Update
 - PUD studied consolidation four (4) times over the past 20-years and have found that it makes sense to consolidate operations on one site, primarily an operations center.
 - This will ensure that customer-owners are provided with the best service and will provide a vast improvement to efficiency.
 - The office building is nearing completion, and the Grand Opening is planned for the Fall of 2023 with a target date of October 7th.

Broadband Action Team Update, Broadband and Digital Equity Plan – Kelli Scott & Jenny Rojanasthien

- The PUD and NCW Tech Alliance, with assistance from Our Valley Our Future, have formed the Broadband Action Team.
- The team has an infrastructure plan that identifies current infrastructure locations, as well as future desired locations.

- A Digital Equity Plan will guide how the State applies for and distributes Federal funding.
 - Noted key findings; digital equity intertwined with other inequities.
 - Plans to provide opportunity to bring more funding to our region in the future.
 - September is slated as digital equity month and will cover many topics.
- o Discussed how take rate and lack of devices are impacted by affordability.
- o Reviewed their Refurbishment Program in which they are partnered with the Wenatchee School District. The school district donated used equipment which is then refurbished by volunteers and given to any community member who requests a device.
 - The team is currently looking for more public partners to increase refurbishment donations.
 - Membership to the NCW Tech Alliance allows them to organize programs such as this.
- o Questions were discussed regarding inaccurate broadband mapping.
 - Bob Shane explained original mapping process and shared the Federal government hired a third party to gather updated information.

Regional Sports Complex Update – Jerrilea Crawford

- Mayor Crawford thanked the Regional Port and Director of Economic Development and Capital Projects, Stacie de Mestre, for overseeing BerryDunn consultants as they conduct the feasibility study.
- o Reviewed that BerryDunn consultants have been paid, in part, by regional agencies and that the team is currently working on community information collection.

CHELAN COUNTY MAYORS UPDATE – Chelan County Mayors/staff provided updates and information.

OPPORTUNITY FOR PUBLIC COMMENT: No comments were made.

COMMISSIONER COMMENTS: No comments were made.

OTHER COMMENTS: Representative Goehner reported that a local government committee is coming to the area on October 9th to tour the Malaga area, discuss growth management policies in Olympia and help the community understand where bottlenecks are. Representative Goehner requested that any cities that would like to weigh in are welcome should reach out to him.
